5) Annual General Meeting of October 7th, 2019

Attending the AGM were 31 members representing 43 votes. Proxies representing 5 votes were registered. The total vote count registered for the AGM was 48 of a total possible 83 votes from the total membership or 58%. This constituted a guorum and the meeting could be considered valid.

6) Board of Directors / Audit Committee - Meetings

A total of 4 Board meetings were held during the period. One Audit Committee meeting was held. Henrik Mjoman resigned from the Board as of February 19th, 2020.

7) Summary of activities

The CanCham DMC (Destination Management Coordination – http://cancham.lv/dmc) initiative had a slow start after its launch in April of 2019, but with the COVID-19 State of Emergency preventing in-person meetings, weekly ZOOM meetings were started for some of our groups which allowed for participation from Canada. Adjustments were also made to the DMC policy and procedures. There are now 11 DMCs in Canada. We encourage members to try to understand the basic concepts and to talk to CanCham's Business Development team on how to get the most out of the initiative. It is clear that a large number of members still do not understand the concept. A special effort will be made to inform members as to the workings of the system, and a special presentation will be made in Trade Facilitation & Export group's presentation evening this fall. We also expect to connect to chambers of commerce in Canada to develop strategic partnerships with our members.

The bookkeeping and administrative services agreement with "TP Riga" SIA was extended. Indra Sproģe-Kalviņa continues her responsibilities to provide bookkeeping and administrative services as per the budget approved by the AGM.

Guidelines for an Ethics Committee were not actioned.

The CanCham Sustainability Committee initiative to explore fee issues and additional sources of revenue was abandoned.

The CanCham stopped using FB Workplace because of difficulties in its use. The decision was made to concentrate information in the CanCham's web site (www.cancham.lv) and FB (https://www.facebook.com/canchamlatvia), and the closed group "CanCham Members and Good Friends" where members can post their own advertisements. Some CanCham members have also undertaken to develop other social media sites to promote the CanCham under the direction of Julie (O'Donohue) Cooke.



8) Special Interest Groups and Group Leaders

- 1. The Board continued the development of a system of Group Leaders for the various interest groups. The intent of this system was to help with coordinating and improving CanCham activities by getting more people involved, but also to provide group leaders the possibility to increase their visibility to enhance their business objectives. Responsibilities of the Group leader included

- Encourage group members to effectively communicate what they have to offer through networking and providing information for the web site such as sell sheets, logo information, news and developments in their companies.
- Help develop a joint strategy so that the group's activities can be offered to the outside.
- Contact and inform group members about CanCham events.
- Work with other groups to meet the needs of their group.
- Maintain contact with group members so that group members do not feel neglected.

Several groups have, or are in the process of forming committees that will help transform ideas into actions and to provide additional resources to improve results.

- 2. Because COVID-19 prevented in-person meetings, in May, we started weekly group ZOOM meetings which allowed us to connect to DMCs in Canada, as well as to the Latvian Embassy in Canada and representatives of the Latvian Investment & Development Agency. The following is a listing of when meetings took place:

Focused on members providing medical services to employees of companies and embassies with foreign employees working in Latvia, the organizing of medical conferences and the development of incoming and outgoing medical tourism.
 - Trade Facilitation & Export Group Zoom meeting 1-200514, 2-200521, 3-200528, 4-200604, 5-200618. Focused on developing strategic partnerships with Canadian businesses for the development of import and export opportunities for goods and services.
 - Construction Related Services Group Zoom meeting 2-200512, 3-200519, 3-200519, 4-200526, 5-200602, 6-200609, 7-200616. Focused on sharing information about active construction or renovation projects, and technology transfer issues.

These meetings will continue in September. Each group will meet every two weeks.

3. "Show and Tell" Member Presentation Events

It has frequently been said that members do not know what services or products are provided by other members. This has been addressed by CanCham Corner social events and "speed dating" networking events.

The CanCham will be launching "Show and Tell" member presentation evenings in the fall of 2020 giving members a five minute opportunity to present their companies in their particular group events. Canadian companies will be invited to participate using ZOOM to enhance these networking opportunities. The meetings are expected to be in-person events. However, should the COVID-19 situation in Latvia worsen, these presentations will still take place using ZOOM.
