## **Process**

- > DMC recruits clients, gives clients discount codes and contacts of BMD. Discount amount approx. 150 EUR is placed on top of the package deal.
- Clients contact BMD, show the discount code unique for each DMC.
- > BMD uses the code to recognise DMC for paying out the DMC's fee.
- > BMD informs medical service providers, confirms the logistics part. If clinics do not provide logistics, the next service provider gets involved. Confirms with the accomodation providers.
- > BMD prepares the package, confirms with the client, invoices client for 25% down payment to reserve appointment, invoices for 75% 2 (two) weeks prior to arrival. If trip has to be organized within a week or two, down payment is 100%.
- Clients organize their own flight, inform BMD about the arrival, departure dates and times.
- > Client arrives, is met by the BMD at the airport, transfered to the accomodation place.
- BMD pays for the services of all service providers on the date client arrives.
- > BMD takes care of the client during the stay in Latvia.
- > After the client departs from Latvia, BMD pays DMC's fees.

## **Process**

### **Reservation policy:**

- > 25% down payment when the package is confirmed
- > 75% down payment prior to arrival. How many days? (2 week)

### **Cancelation policy:**

- ➤ Client cancels the trip for appropriate reason at least one week prior to the appointment date, client is eligible for 75% down payment refund. No down payment refund after that date. If trip was organized within short notice and canceled by client, refund of 50% of down payment applies.
- Medical service provider cancels treatment, BMD has the right to offer service of other medical care provider and confirm with the client. If client rejects the offer, full refund applies.
- BMD cancels trip, full refund applies.

#### Legal framework: ASSISTANCE REQUIRED

> BMD is a contracting party with DMCs, clients, service providers, consultants

### Responsibilities and professional liabilities: ASSISTANCE REQUIRED

- DMC: information to clients and BMD.
- > BMD: dealing with DMCs, clients, service providers, accounting billing and payment to service providers, DMCs. Professional and civil liability insurance.
- Medical service providers: treatment, medical documentation, follow up period. Professional and civil liability insurance.
- Accomodation providers: Civil liability insurance?
